Driving and Parking Regulations
2017 - 2018

1. All Ryan students who drive vehicles on DISD property during school hours must register and receive a parking permit from the attendance office.
2. All permits must be sold and issued by the school. Purchasing a permit from another student will result in loss of the permit. Permits will be sold only to students with a valid driver's license. Parking permits may be purchased throughout the year at the following rates: (August, September & October = \$25), (November & December = \$20), (January & March \$15), (April, May & June \$10.00) There is a \$5 replacement fee for lost or damaged permits. Contact the AP Office immediately to report a lost or stolen permit.
3. Carpooling is encouraged. Students may share a parking space if all the different vehicles are registered in the Assistant Principals' Office. However, there is no borrowing, lending, giving, selling or exchanging of vehicle permits and assigned spaces among the students **without permission from the AP Office**. Towing, loss of permit, \$10.00 fee or other disciplinary action will be the penalty for noncompliance with this rule.
4. Student parking is provided in designated parking slots. Driving or parking on any of the grassy or dirt areas of the grounds, in areas designated for faculty or visitors, or any other unauthorized area is prohibited. All traffic control devices, signs, and directions must be obeyed at all times.
5. Vehicles are to be parked within the painted lines of the assigned slots.
6. There will be no loitering or sitting in vehicles on the parking lot during school hours.
7. Students are to drive slowly and cautiously while on campus and obey all safety precautions. The maximum speed limit on campus is 10 MPH.
8. **Any car parked on the RHS campus may be searched at any time.**
9. Fines for parking violations are **\$5.00 for each violation**, if paid within five (5) school days. After that time, unpaid fines may result in a loss of driving privileges for a minimum of six (6) weeks.
10. Parking privileges may be suspended for matters other than parking or moving violations. Instances may include, but are not limited to, disregarding safety regulations, leaving campus without proper authorization, false information on the registration card, failure to stop at the guard station, **more than 3 tardies in a six week period, and more than 4 UNV absences in a semester**, etc.
11. Vehicles that have not been registered, vehicles that are illegally parked, or registered vehicles that are not parked in their assigned space will be towed to an impound area at the driver/owner's expense.
12. Parking permits remain the property of the school. Students who withdraw from school or who no longer require or desire a parking space must return the permit to the office and will lose their parking space.
13. Early dismissal permits must be prominently displayed below the rear-view mirror on the front windshield. Regular parking permits must be displayed on the rear-view mirror, where the number can be read from the outside of the vehicle. Permits must be displayed at all times while the vehicle is on school property.
