

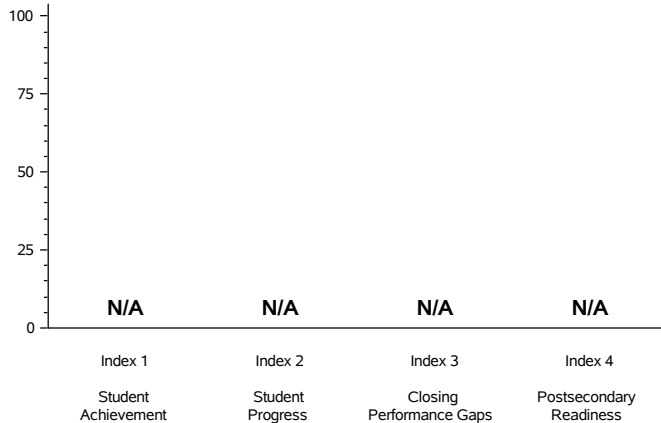

**2016 Performance Index**
