REQUIRED DOCUMENTATION:

Collecting the below required documentation before you are screened by an agency can help speed up the process.

- **Verification of Income or Job Loss** - Written communication from employer on company letterhead stating household's loss of job or income
- **Current Financial Statements** - Copy of current bank statement and current account balance for every adult in the household; copy of 401k retirement account statement for all adults in the household if applicable
- **Documentation of Lease or Mortgage Requirements** - Needs to reflect household's name, address and amount owed.
- **Copy of Utility Bill (If applicable)**

**Assistance is subject to eligibility. Length may vary based on household need.
Payment is made directly to vendors and never directly to households.
Because of high volume, households may wait 1-3 weeks for financial assistance.**

- Estados financieros actuales (SE REQUIERE para recibir ayuda económica para la Renta/Hipoteca o gastos de servicios públicos) – Una copia de su estado de cuenta actual y el saldo de cuenta corriente para cada adulto en el hogar y una copia del estado de cuenta de jubilación 401k para todos los adultos en el hogar si le corresponde.
- Documentación de los requisitos de arrendamiento o hipoteca (REQUERIDO para recibir ayuda para la Renta/Hipoteca).
- Factura de servicios públicos (SE REQUIERE para recibir asistencia/ayuda para los cobros de servicios públicos).
