#### NAMING FACILITIES

### **DISD Board of Education:**

I am writing to nominate Bob Estes's name for the name of the new elementary school. I was fortunate to have taught under Mr. Estes at Frank Borman Elementary School for 26 years. I feel qualified to nominate his name.

As principal, academics were important to him, but it was also his goal for children to develop responsibility, independence, patriotism, good citizenship, character, and an appreciation for the fine arts. He began each school day with the pledges and patriotic songs led by students over the public address system.

"A master teacher"—that describes Robert Estes. It was Mr. Estes' philosophy that a well-rounded education did not end with the 3 R's. Through Bob's efforts, DISD had its own "arts magnet school". Bob planned special fine arts assemblies such as those provided by UNT and TWU. Assemblies showcased musicians from harpists and guitarists to opera companies and professional square dance callers. Students were taught theater arts, movement and dance. Once a Victoria, Texas school choir dropped by to sing for us because their director had heard so much about the talented students at Borman Elementary. Because of Bob Estes, we also had the good fortune to host the Texas Boys Choir in concert.

An organist, himself, Bob's leadership on the Denton Arts Council opened many doors for the children of Borman School. Through his efforts, we were adopted by Penders Music Co. and the Allen Organ Co. They provided our school with invaluable teaching materials and performances by professional musicians and dancers, and in 1988, the Allen Organ Co. presented the school with an organ, making Borman the only school in Denton to own its own organ. With this organ, Bob and the other organists on our faculty provided accompaniment for musical programs. In addition, Mr. Estes and these teachers actually taught organ lessons to individual students free of charge.

Further evidence of Mr. Estes' support for the arts could be seen in the school choir, the cloggers, and the Borman handbell choir which performed before various community organizations and schools throughout the years. Bob started the first handbell choir in Denton at Borman School. For many years it was the sole handbell choir in Denton, and Bob was its director. The Borman handbell choir had the honor of performing for the 1990 Texas Music Teachers' Association Convention in San Antonio, and in 1991 our handbell choir performed at the White House in Washington, DC at Christmastime.

Bob Estes was also a supporter of the visual arts and literary arts. Borman School participated in a number of exhibitions, both literary and visual, some from as far away as Washington, DC, Japan and South America. In addition, a yearly internship by a resident artist was a school tradition. One such artist was professional poet Charles Behlen who taught students creative writing.

Likewise, one should not overlook the contributions Mr. Estes made toward fine arts at the college level. He sponsors an organ scholarship at UNT, where, perhaps one day, the recipient of this scholarship will be a former Borman "musician".
