1. Title One Program

- Wilson receives \$88,320.00 in Title One Money. This money comes from the Federal Government and is based on the number of our enrolled students who qualify for free or reduced lunch. Currently, that is 44% of our students.
- Our school uses \$59.147.00 on a Math instructional coach and interventionist.
- Campus Title funds also provide \$1,248.00 for supplies and materials for parent involvement and \$27,925.00 for Title 1 tutors, teacher planning time, staff development, and teacher collaboration.
- Denton ISD provides supplemental Learning Literacy Facilitators, Descubriendo la Lectura teachers, and a Bilingual literacy coach and interventionist.
- Parents have the right to be involved in our school programs through volunteering, observing classroom
 activities, participating in the decisions relating to the education of their children, and in reviewing and
 revising the campus improvement plan, parent and family engagement policy, and school-parent
 compact.
- Additionally, parents have the right to request information regarding the qualifications of their child's teacher and may do so by talking with the school principal.

2. School-wide program plan

- The Campus Leadership Team (CLT), which includes teachers, parents, business and community representatives has developed a Campus Improvement Plan (CIP); and it serves as our Title I program plan.
- Our Wildly Important Goals (WIGs) this year are:
 - i. Improve academic performance of all students at the On Level/Meets and Above Level/Masters by 5% in reading and math from August 2020 to May 2021 when comparing beginning of the year data to end of the year data.
 - ii. By May 2021, we will provide a safe and secure climate for learning that will prepare students to become lifelong learners as evident by a 10% increase in positive perception through the Campus Culture & Climate Survey
 - iii. Establish a high quality and robust professional development plan for all teachers to meet the needs of the changing demographics and needs of the community.
 - iv. Increase student engagement in extracurricular clubs as well as college and career awareness

- Grades 3-5 State of Texas Assessment of Academic Readiness (STAAR), as well as report card assessments and common assessments.
