## Elementary and Secondary School Emergency Relief (ESSER) Grant

ESSER III Grant - Authorized through American Rescue Plan (ARP) signed into law, March 2021.

Availability - March 13, 2020 (pre-award) to September 30, 2024 (with carryover).

Grant Allocations for Denton ISD - USDE has released  $\frac{2}{3}$  of state's allocation and will release final  $\frac{1}{3}$  after approval of state's plan this summer or early fall.

Initial Allocation (two-thirds)	Remaining Allocation (one-third)	Total Allocation Amount	
\$15,140,817	\$7,570,408	\$ 22,711,225*




#### RESULTS Al Generated Themes



## **Supported Teachers**

#### **Zone Impact Coaching Teams** (\$785,000)

- Each zone will have "Impact Coaches" to work with elementary, middle school, and 9th gr Algebra I. A district-wide sustainable coaching model will be used with a united vision and mission to:
  - Support w/leadership positions (1 elementary and 1 secondary specialist) responsible for leading and developing the Zone Impact Coaching Teams;
  - Include four new impact coaches for secondary campuses (one per zone)plus 4-6 secondary math interventionists;
  - Include one district-level Bilingual/ESL specialist to support the campus leadership with capacity building and intervention for emergent bilinguals and ESL students;
  - Support and deliver professional development through a district coaching plan with aligned instructional coaching playbook;
  - Coordinate efforts with specialized programs (special education, 504, dyslexia) for extensions of intervention and coaching;
  - Supervise progress monitoring efforts;
  - Guide and assist the analysis of all diagnostics used for Beginning of Year, Middle of Year, and End of Year student growth using a Denton ISD list of assessments; and,
  - Coordinate mental health training/supports for teacher well-being.



## Rigorous Instructional Materials

#### **Curriculum Writing Acceleration** (\$90,000)

- Adapting our current curriculum documents for:
  - Including social and emotional learning options within formative assessments of academics (formative assessments, lesson planning, conferring, and student SEL Goal-setting);
  - Developing elements within units that scaffold learning as needed based on student loss data sets;
  - Developing units for scaffolding in elementary Spanish and Translanguaging in multiple content areas;
  - MS and HS Reading Intervention Course Development; and,
  - MS and HS Math Intervention Course Development.


## **More Time**

#### **Summer Programming (\$620,500)**

- Elementary Jump Start
- Middle School Jump Start
- ESL Jump Start
- Algebra I Jump Start
- Boost Program

#### **Intensive Tutoring** (\$300,000)

- Tutorial opportunities during the school day.
- A-Team Tutors: hire retired teachers, counselors, highly trained university students, etc.
- High Impact Tutoring and other evidence-based strategies will be used.
- Emphasis on math and literacy.
