Q 1. Who is the current incumbent?

A 1. International Investigators

Q 2. When was the current incumbent awarded the contract?

A 2. The contract began with our 2011-2012 school year.

Q 3. What is the estimated usage (number of annual hours) of prior contract?

A 3. There are two (2) calendars posted on our webpage. The Calendar 2017-2018 After Hours Security notes the days and hours.

Q 4. What is the estimated total number of annual hours for this contract?

Q 5. What is the current Bill Rate?
