# BRASWELL HIGH SCHOOL PARKING REGULATIONS

Use of the school parking lot is a privilege and is provided for your convenience. Students may park in the school lot if they agree to follow the rules and if they purchase a parking permit. Students are expected to follow directives of the school staff and security officers. The rules established for the parking lot are to promote safety for all the students who use the lot whether they are riding a bus or in a car. The school is not responsible for damage to vehicles parked in the lot or for lost or stolen items left in the car

1. Students are required to park in all lots except for the Staff parking lot located in the front of the school. The vehicle tag MUST be hung from the rear-view mirror in clear view at all times during the school day. **Students shall not park in the Staff lot. Students who fail to park in the designated areas will face disciplinary action, which can include loss of parking privileges. After multiple warnings the vehicle will be towed at the owner's expense.**
2. Students are expected to follow all state and local laws for operating their vehicle while on campus. No student is allowed to ride in the bed or tailgate of a pickup truck or the outside of a vehicle. **Any reckless or careless driving can result in loss of parking privileges and/or a ticket issued by the police.**
3. Any student in possession of a FRAUDULENT parking pass or in possession of someone else's permit will not be allowed to park or drive on school property and will face disciplinary actions, including suspension of driving privileges.
4. Vehicles parked on school property are subject to inspection and searches by school personnel, local authorities, and drug canines. All vehicles and drivers must comply with state laws for licenses, insurance, and state inspection. **The following items are NEVER allowed on campus inside or outside of a vehicle:**
  - ILLEGAL DRUGS OR PARAPHERNALIA
  - OVER-THE-COUNTER DRUGS or PARAPHERNALIA which violate the Denton ISD policy
  - WEAPONS, including guns, or look-alike guns, knives, clubs, or any type of ammunition and/or any weapon designated unlawful by Texas law.
  - ALCOHOL and ANY NICOTINE DELIVERY PRODUCTS. These are a violation of Texas state law and may result in termination of parking privileges and Denton ISD Code of Conduct discipline.
